Our mission

My First Bicycle's mission is to help financially disadvantaged kids own a bicycle by donating a package consisting of a bicycle, helmet and lock. We are dedicated to improving participation and inclusivity in cycling for Canadian youth.

Eligibility requirements

Child must be between the ages of 6 and 16

The bicycles we provide are best fit for children between these ages and that these ages are crucial for engaging children in their own active modes of transportation.

Applications should be completed by the child's parent or guardian


OR individual must have permission from the parent or guardian, along with all necessary documentation needed to apply (teachers and mentors are welcome).

Child must be from a low-income household

The Government of Canada has created an income threshold measurement called Low Income Cut-Off (LICO) which is used by charities to target people who may qualify for specific charitable work.

We will provide a bicycle, helmet, tools and lock to ensure the safety of your child and the bicycle.
